## Dear Property Owner:

This letter is to inform you that Davies Builders, LLC, Susan Shapiro Barash, and the Township of Long Beach are submitting a Freshwater Wetlands application to the New Jersey Department of Environmental Protection (NJDEP), Division of Land Resource protection (DLRP) for a Letter of Interpretation (LOI): Line Verification to verify the delineated limits of coastal mapped wetlands and width of the transition area within the above-referenced site. All LOI applications require that property owners within 200 feet of the site be notified via certified mail. A certified list of property owners within 200 feet of the above-referenced site was obtained from the Township of Long Beach. The LOI application does not authorize a proposed project. If a proposed project requires any other approvals from the NJDEP Division of Land Resource Protection, another notice will be sent via certified mail. No action is required on your part unless you wish to comment on this application.

The 13.54±-acre is bordered by residential development to the north, Newport Drive to the south, Little Egg Harbor Bay to the west, and Steven Avenue and residential development to the east. No freshwater wetlands were identified within the site. Please find enclosed the survey. Below please find the legal notice.
